
Property Sales

June Property sales were 44, down -20.0% from 55 in June of 2017 and 18.9% higher than the 37 sales last month. June 2018 sales were at their lowest level compared to June of 2017 and 2016. June YTD sales of 203 are running -1.9% behind last year's year-to-date sales of 207.



The Median Sales Price in June was \$1,117,500, down -15.7% from \$1,325,000 in June of 2017 and up 1.6% from \$1,100,000 last month. The Average Sales Price in June was \$1,348,822, down -13.0% from \$1,549,959 in June of 2017 and down 0.0% from \$1,348,961 last month. June 2018 ASP was at the lowest level compared to June of 2017 and 2016.



Inventory & MSI

The Total Inventory of Properties available for sale as of June was 391, up 1.8% from 384 last month and down -12.3% from 446 in June of last year. June 2018 Inventory was at the lowest level compared to June of 2017 and 2016.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The June 2018 MSI of 8.9 months was at its highest level compared with June of 2017 and 2016.


MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for June was 69, down -24.2% from 91 days last month and down -62.5% from 184 days in June of last year. The June 2018 DOM was at its lowest level compared with June of 2017 and 2016.


Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The June 2018 Selling Price per Square Foot of \$348 was up 3.9% from \$335 last month and down -16.3% from \$416 in June of last year.



Selling Price vs Listing Price


The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The June 2018 Selling Price vs List Price of 92.5% was down from 93.2% last month and down from 94.0% in June of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in June 2018 was 69, down -40.5% from 116 last month and down -19.8% from 86 in June of last year.
